The Pecos Valley Potters' Guild Art Sale is a noted arts and crafts market held annually in Roswell, New Mexico. Each year, the Guild selects quality guest artists working in a variety of media to participate in the Sale, with an emphasis placed on unique and original art and fine crafts. **The Pecos Valley Potter's Guild invites you to submit your work for inclusion in this year's juried Art Sale.**

Booth Fees

10 x 10 Booth = \$225; 5 x 20 Booth = \$225 (limited quantity available). All booths are located inside the main exhibit hall of the Roswell Convention & Civic Center

Application Submission

Guest Artist applications will be reviewed by the Jury Committee on an ongoing basis in the order the application is received beginning **May 15, 2019**.

Rules and Regulations

- **No Jury fee is required.** Each artist must submit booth fee with application form and a minimum of three digital images or photos representative of the type of work to be displayed at the Sale. **Please include a photo of your booth set up.** Digital photos are preferred and may be emailed to: PVPGArtShow@gmail.com Booth fee will be returned if an Artist is not accepted.
- **All work must be original and be executed by the Artist.** No imported, manufactured, commercial, or kit work will be accepted. The Jury Committee will be looking for quality and originality.
- Work exhibited must reflect the quality of work depicted in the application photos. **Artists may only exhibit work in the media category(ies) in which they have applied and have been accepted by the Jury Committee.**
- Booths may be shared; however, each artist exhibiting work must submit an application and must be juried independently.
- Artists are expected to be present and exhibiting work for all hours of the Sale. Artists may not employ professional representatives. Family members or friends may assist. **The application is invalid without booth fee and photos of work.**

Booth Decorations

Artists must provide his or her own booth structures. As a courtesy to other artists, structures and displays may not extend out on the allotted booth space. No duct tape or masking tape is allowed on the floors or walls of the Roswell Convention & Civic Center. **The only tape allowed is RCVB blue painters tape.** Only standard push pins are allowed to affix items to the walls. Artists must supply their own extension cords and any additional lighting required.

Liability

Security will be provided during Sale hours. **Participants exhibit all work at his or her own risk.** Artists are encouraged to have business insurance that will allow coverage while at the PVPG Sale. The Pecos Valley Potters' Guild will not be responsible for any theft, damage, loss or claim whatsoever arising from any cause, nor incurred by reason of failure of the exhibitor to obtain insurance or failure of such insurance to cover any loss.

Silent Auction

Artists are encouraged to provide an item for the Silent Auction. Proceeds from the auction are used to fund ceramic art education projects in the Roswell area.

Application Procedures

- **Completed application form**
- **Three photos** or digital images per media category. All photos must be representative of the quality and variety of current work to be displayed at the Sale. Please include a photo of your booth setup. Photos should be labeled with the Artist's name and medium. Digital photos may be submitted on a disc or via email to PVPGArtShow@gmail.com
- **Check** in the amount of \$225 for booth fee. Check will be returned if Artist not accepted.
- **Deadline for refunds is September 26, 2019.**
